### ABOUT MCAG

Merced County Association of Governments (MCAG) is an association of city and county governments, with members who meet to solve regional problems such as transportation, solid waste, and air quality. This Association of Governments is where the cities and the county come together as equal partners to solve problems that can only be accomplished by working together.

MCAG was formed through a Joint Powers Authority (JPA) signed by member jurisdictions in November, 1967. As a regional collaborative agency, MCAG serves in a number of transportation planning roles in Merced County based on local, state, and federal designations. These designations offer increased funding for MCAG activities, primarily in transportation planning for the unincorporated areas of Merced County.

### **ABOUT LAFCO**

The Local Agency Formation Commission (LAFCo) is an independent commission created by the State to promote the wise use of land resources while providing for the present and future needs of a community. LAFCo Commissioners have a responsibility to exercise their independent judgement while making decisions concerning appropriate local governmental boundaries and service providers.

To guide their decisions, the Merced LAFCo Commission has adopted the following four goals:

- 1. Planned, well-ordered, and efficient development patterns.
- 2. Governmental services are delivered efficiently and effectively.
- 3. The need to provide for urban development is balanced with the conservation of open space and prime agricultural lands.
- 4. Urban land use patterns maximize the opportunity for local jurisdictions to provide their fair share of regional housing needs for all income levels.

These goals were created to carry out the State's legislative intent codified within the Cortese-Knox-Hertzberg Local Government Reorganization Act (CA Govt Code § 56001) of 2000: "The Legislature recognizes that the logical formation and determination of local agency boundaries is an important factor in promoting orderly development and in balancing such development with sometimes competing state interests of discouraging urban sprawl, preserving open space and prime agricultural lands, and efficiently extending government services. The Legislature also recognizes that providing housing for persons and families of all incomes is an important factor in promoting orderly development."

#### ABOUT THE SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT

The San Joaquin Valley Air Pollution Control District is made up of eight counties in California's Central Valley: San Joaquin, Stanislaus, Merced, Madera, Fresno, Kings, Tulare and the San Joaquin Valley Air Basin portion of Kern.

The Valley Air District is governed by an fifteen member Governing Board consisting of representatives from the Board of Supervisors of all eight counties, one Health and Science member, appointed by the Governor, one Physician, appointed by the Governor and five Valley city representatives.

#### The Air District's Mission

The San Joaquin Valley Air District is a public health agency whose mission is to improve the health and quality of life for all Valley residents through efficient, effective and entrepreneurial air quality management strategies. Our Core Values have been designed to ensure that our mission is accomplished through commonsense, feasible measures that are based on sound science.

#### The Air District's Vision

Healthful air that meets or exceeds air quality standards for all Valley residents. The District is a leader in air-pollution control. Valley residents take pride in our collective efforts to continuously improve air quality.

#### **Core Values**

**Protection of Public Health** – The District shall continue to strive to protect the health of Valley residents through efforts to meet health-based state and federal ambient air-quality standards, based on science and prioritized where possible using health-risk reduction strategies.

Active and Effective Air Pollution Control Efforts while Seeking to Improve the Valley's Economic Prosperity and Grow Opportunities for All Valley Residents – District staff shall work diligently to adopt and fully implement cost-effective air pollution-control measures, provide meaningful incentives for reducing emissions, and develop creative alternatives for achieving emissions reductions.

**Outstanding Customer Service** – District staff shall work to provide excellent customer service for stakeholders in activities including: rule and plan development; permitting and emissions inventory functions; compliance activities; financial and grant-funding transactions; and responses to public complaints and inquiries.

**Ingenuity and innovation** - The District values innovation and ingenuity in meeting the challenges we face. Examples of this spirit of innovation include developing programs that provide new incentives for emissions reductions, and providing alternate compliance strategies that supplement traditional regulatory efforts and generate more emissions reductions than could otherwise be reasonably obtained.

**Accountability to the public** – The District serves, and is ultimately accountable to, the people of the Valley for the wise and appropriate use of public resources, and for accomplishing the District's mission with integrity and honesty.

**Open and transparent public processes** – The District shall continue to provide meaningful opportunities for public input and be responsive to all public inquiries.

**Recognition of the uniqueness of the San Joaquin Valley** – The Valley's meteorology, topography and economy differ significantly from those in other jurisdictions. Although it is valuable to review and evaluate efforts of other agencies, we must consistently look for solutions that fully consider the Valley's unique needs.

**Continuous improvement** –The District works to continually improve its internal operations and processes, and strives to streamline District operations through optimally utilizing information technology and human resources.

**Effective and efficient use of public funds** – The District shall continually strive to efficiently use all resources and to minimize costs associated with District functions.

Respect for the Opinions and Interest of All Valley Residents – The District shall respect the interests and opinions of all Valley residents and fully consider these opinions, seeking collaboration with federal, state, and local agencies, agriculture, businesses, community groups and residents in carrying out the District's mission.

Robust Public Outreach and Education on Valley Air Quality Progress and Continuing Air Quality Efforts – As we move forward in achieving our mission, the District shall continue its ongoing efforts to educate the public about air quality, and the significant clean air investments and air quality progress that have been made in the Valley.

# CITY COUNCIL LIAISON – LIVINGSTON PLANNING COMMISSION Liaison: Maria Soto

The Planning Commission acts in an advisory capacity to the City Council on land-use and development issues. Responsibilities of the Planning Commission include:

- Interprets, administers, and enforces the provisions of the City's Zoning Ordinance and other land use regulations, in such a way as to carry out the intent and purpose of the General Plan as interpreted on the official Zoning Map;
- Acts on Variances from the provisions of Title 5 regarding the development of land, construction, enlargement or alteration of any building or structure;
- Acts on Use Permits, Variances, and Parcel Maps. It revokes Use Permits as necessary; provides interpretations of zoning ordinance;
- Provides recommendations to the City Council on Site Plan & Design Reviews, Rezonings, Tentative Maps, Development Agreements and General Plan Amendments.

The Planning Commission meets on the second Tuesday of each month at 7:00 p.m. Planning Commission meetings are held at the City Council Chambers, 1416 C Street, Livingston, CA 95334.

# CITY COUNCIL LIAISON – PARKS, RECREATION AND ARTS COMMISSION

The Parks, Recreation and Arts Commission acts in an advisory and volunteer capacity in the development of parks, recreation and art opportunities for Livingston residents. In their capacity, the Parks, Recreation and Arts Commission shall:

 Recommend to the City Council a Parks and Recreation Master Plan. If directed by the City Council, the commission shall recommend to the City Council a Parks, Recreation and Arts Master Plan, either in lieu of or in addition to, the Parks and Recreation Master Plan. After any initial Master Plan has been adopted by the City Council, the commission shall periodically review the Master Plan and make appropriate recommendations to the City Council.

- Recommend to the City Council individual Park Master Plans for each park in the City of Livingston.
- Constructively encourage public recreational and art activities in Livingston.
- Recommend projects, legislation, policies, funding allocations, and other measures, programs, or activities for the development of park, recreation and art opportunities in Livingston.
- Act in an advisory capacity to the City Council in all matters pertaining to recreation.
- Act in an advisory capacity to the City Council in all matters pertaining to art or art programs within the City.
- Carry out projects, programs, or activities as directed by the City Council.
- Consider the annual budget for recreation during the annual budget process and make recommendations with respect thereto to the City Council.
- Initiate, sponsor, and promote involvement, activities and contributions by the private sector for the development of parks, recreational and art activities in the City.
- Assist in the planning of a Recreation Program for City residents, promote and stimulate public interest therein, and solicit the cooperation of school authorities and other public and private agencies interested therein. (Ord. 633, 2-20-2018)
