IMPORTANT FOOD VENDOR DEADLINE Sept. 15, 2023 5PM CITY HALL <u>NO EXCEPTIONS</u> This is to Comply with the <u>Health Department.</u> <u>Vendors must have City</u> <u>booth approval prior to</u> <u>getting health permit.</u>

<u>Special Event Insurance</u> <u>is required.</u>



- Booths selling music or creating noise will not be allowed.
- No Political Booths.

- 3. Set-up is to take place between 4:30pm and 5:30pm.
 - No vehicles will be allowed on the street after 5:45pm until 9:15pm.
- 5. Bring your own tables, chairs etc. They will not be provided for you. **NO EXCEPTIONS.**
- 6. Keep and leave your booth and surrounding area clean. <u>You MUST provide a</u> <u>trash container inside your booth</u>.
- 7. Food Applications must be submitted by <u>September 15, 2023</u> and Merchandise and Informational Booths must be submitted 1week prior to the date of usage. Applications are taken at City Hall, 1416 C ST, Livingston M-F, 8am -5pm.
- 8. There will be <u>no exclusive rights on non-alcoholic drinks or merchandise</u>. We will allow duplications on some food items.
 9.NO VEHICLES WILL BE ALLOWED ON THE STREET DURING THE FAIR. NO EXCEPTIONS!!!
- 10. **Food Booths must have a Health Permit from the Merced County Health Department. This must be issued 2 weeks prior to the event. They will not issue permits after the 2 week deadline. Each food booth must comply with their specifications. Health Permit Applications may be picked up and returned with event application at City Hall.
- 11. To assist in the success of this event, you may not tear down your booth earlier than 9pm. All Selling must stop at 9pm due to minimal time for clean up and the streets to be reopened. Failure to comply to either of these two issues will result in the revoking of your application to participate with no refunds and possible charges for overtime you have caused by not ending on time.
- 12. Items which use our guests as entertainment will not be allowed. These items include, but are not limited to, palm readers, fortune tellers, silly string, disappearing ink, and poppers.

Booth Fees are as follows: 10x10 merchandise, food and information booths - \$25 per week. Local Non-Profit Groups with information only are free. Please mail your completed application to: Livingston Recreation, 1416 C St. Livingston, CA 95334.
