LMC Title 7, Chapter 4

## **COUNCIL SELECTION REQUIREMENTS**

Organizations must meet the following eligibility qualifications to submit a FIREWORKS BOOTH SALES COUNCIL SELECTION APPLICATION:

An application must be fully completed at time of submission; incomplete applications will not be accepted. Along with the application the following items must accompany it.

- A Certificate of tax exemption from the Internal Revenue Service or The Secretary of State.
- Must include a brief statement of services and benefits provided to the citizens of the City of Livingston.
- o Location of the principle permanent meeting place of the non-profit organization.
- o Roster of 15 Active members.
- o Non Refundable application fee of twenty five dollars (\$25).
- A LETTER TO THE COUNCIL STATING WHY YOU BELIEVE YOUR ORGANIZATION DESERVES A BOOTH WITHOUT GOING THROUGH THE LOTTERY PROCESS

If the City Manager determines the non-profit organization is not qualified, the organization will be notified and will have fifteen (15) days from the date of notification to submit a letter of appeal. The appeal will be heard by the city council prior to the Lottery.
